

## END USER SOFTWARE AND DATABASES LICENSE AGREEMENT (EULA)

This License Agreement concerning the software MatCalc and related Databases (hereafter individually and/or jointly referred to as "MatCalc-Package") is entered by and between the end user (hereafter called the "Licensee"), and MatCalc Engineering GmbH, Getreidemarkt 9, E308, BE 0501, A - 1060 Wien, Austria (hereafter called "MC-Eng"). It is hereby agreed as follows:

### 1. Preamble

The software MatCalc has been developed and is being developed in the course of scientific research at TU Wien. Related MatCalc software Databases are developed by MC-Eng. MC-Eng is the exclusive agency to sell the MatCalc software licenses. MC-Eng is also responsible to sell encrypted Database license(s) including maintenance and support of the MatCalc-Package. The software package MatCalc and the related databases are licensed, not sold.

This EULA is applicable for the software MatCalc-Package for Windows, Linux and Mac OSX. This Agreement also covers any future upgrades of the software MatCalc and the related database(s) and any additional Single or Multi License(s) and Network License(s), and additions thereto, provided to Licensee by MC-Eng.

### 2. License

MC-Eng (or its appointed agent) grants Licensee license(s) to use the software MatCalc-Package on a non-transferable and non-exclusive basis pursuant to the terms and conditions of this Agreement.

Licensee right to use MatCalc encompasses the right to use only the Software(s) and Database(s) Licensee has paid for.

The Licensee rights to get "MatCalc and the related database(s) update" including "Maintenance and customer support" will automatically terminate one (1) year after the date MC-Eng (or its authorized agent) sent Licensee the license key enabling Licensee to use the MatCalc software. Agreement to extend validity of these rights is set forth under Section 5.

### 3. Publication

Data derived by using the software MatCalc-Package may be published internally within the Licensee or publicly in literature, provided the Licensee acknowledges its use by a suitable reference such as footnote or within a reference list.

### 4. Obligations of the Licensee

Licensee will not make or permit to make any copies of MatCalc-Package other than are necessary for its use, and will not sell, license, sublicense, rent, lend MatCalc-Package and will not reverse engineer, disassemble or decompile - neither in parts nor as a whole.

Licensee is not allowed to modify, amend, alter, revise, enhance or otherwise change the software MatCalc-Package or use the software or databases in a way that would endanger its quality as a trade secret.

The license granted hereunder permits use of MatCalc-Package only at the designated site as specified in the relevant quotation(s).

Licensee is only authorized to use the MatCalc-Package for its own internal purposes and in no event use it as part of a data services operation or otherwise for a third party.

### 5. Maintenance and Support (M&S)

Update, maintenance and support of the software MatCalc and Database(s) are governed by "TERMS AND CONDITIONS FOR MATCALC-PACKAGE MAINTENANCE AND SUPPORT".

### 6. Liability

MatCalc has been developed and is being developed at TU Wien. Related Databases are developed by MC-Eng. MC-Eng warrants that MatCalc-Package has been developed by applying scientific care and in compliance with the accepted state of the art. In addition, liability of the Parties, their legal representatives and agents for claims for damages of the other Party shall be limited to damage which was caused by willful intent.

MC-Eng does not guarantee or warrant the accuracy of results or otherwise from use of MatCalc-Package and shall not be liable for any type of loss incurred as a result of its use. MC-Eng also does not guarantee or warrant that activities permitted under this License Agreement and involving use of MatCalc-Package will not constitute infringement of any patent or other intellectual property rights owned by any third party, and MC-Eng assumes no liability, whether express or implied, for MatCalc-Package's infringement upon present or future patents or other industrial property rights of any third party. For breach or non-performance of this License Agreement, the only remedy available to the Licensee is to terminate this License Agreement.

### 7. Termination

This License Agreement may be terminated by MC-Eng in the event of a breach by the Licensee of any of the conditions of this License Agreement and the Licensee should fail to remedy such breach within ten (10) days after receipt of written notice.

### 8. Miscellaneous

If any provision of this Contract is ineffective, the validity of the remaining provisions shall not be affected. Ineffective provisions shall be deemed replaced by effective provisions, which come as close as possible to the original purpose of the Contract.

This Agreement shall be governed by the laws of the Republic of Austria without giving effect to its conflict of law principles. For any legal disputes, the Parties agree on exclusive jurisdiction of the Vienna Commercial Court or, at the choice of the plaintiff, of the court having jurisdiction at the place of the defendant's registered office.

Modifications of or amendments to this Contract, in particular an agreement to abolish the formal requirement of written form in future, shall be made in writing.

This Agreement is the entire agreement between the Licensee (including Licensee employees and other end users) and MC-Eng. In the event MC-Eng enters into terms of use, end user agreements, or other agreements or understandings, whether electronic, click-through, or shrink-wrap, and whether verbal or written, with Licensee employees or other end users, such agreements shall be null, void, and without effect, and the terms of this Agreement shall apply.
